- 3. OSUPD Dennis Jeffrey & Monica Moll, Blankenship Hall
  - a. What is OSUPD's collaboration with regional campuses?
    - i. There are sergeant's on regional campuses, sometimes there is security staff or a few officers on sight. Most officers work Monday through Friday during the day while the security staff takes over at night.
    - ii. Due to lower crime on regional campuses, one may see lower OSUPD on these campuses.
  - b. Does OSUPD have a way to trace calls from anonymous numbers to OSU phones?
    - i. Cellphones and 911 calls will always be "traced" just due to technology. Calls directly university phones can trace calls, but if using masking things tend to be difficult.
    - ii. To report individuals should use the non-emergency phone number.
  - c. How does OSUPD proactively reach out to and work with groups that sometimes feel overpoliced? Both on campus and within the surrounding community.
    - i. CSA could be a great place to support these individuals. It can be difficult for police to be welcomed into spaces when that trust isn't there.
    - ii. Question from group: With the latest protests, many students are members of overpoliced communities. These students may not trust police and miss the support that can come from police.

- 1. Student Life has partnered with OSUPD to start having these conversations. Some missteps could have come at primarily meeting with leaders rather than whole communities.
- d. What is the approach OSUPD takes to balance safety and privacy concerns?
- e. What's the criteria to determine what is a large enough threat for Buckeye Alert?
- f. What do they consider "on campus" -- for Buckeye Alert and in general? Jurisdiction of OSUPD vs City of Columbus
- g. Can you provide some stats on the positive and alarming changes in crime rate statistics?
- h. Work to improve off campus safety -- joint patrols. How many are done yearly? Has it been effective
  - i. Joint Patrol 4 OSUPD ride with Columbus PD Wednesday through Saturday. Success has come through student support through OSUPD being present with Columbus PD.
- i. Commuter parking lots -- are the mobile cameras still working?
  - i. There are very few now. However, you will see them where coverage is limited
- j. Collaboration with emergency management and fire prevention?
  - i. Emergency plans are a major task for collaboration.
  - ii. Primary liaison for Columbus Division of Fire; There is support for regional campuses though Table Top Talks.
  - iii. Emergency staff are over Buckeye Alerts
    - 1. Buckeye Alerts situations on campus; immediate awareness of a threat or concern (Less commonly used)
    - 2. Timely warning (Public safety notice) typically through email, used on patterns crimes or concerns. These are more common/more used as an acknowledgement of a situation.
    - 3. The Citizen App is a useful tool for off-campus concerns. More frequent alerts but may not always be a reliable source of information for immediate information.
    - 4. City police have a community crime map verified by the department.
- k. Biggest goal you want to accomplish as police chief?
  - i. Retain staffing monitoring Gateway and Carmington requires more folks so keeping but also recruiting officers. Ideally using OSU as a pipeline, those who want to provide safety to a place they care about.
    - 1. Becoming a new officer in Ohio is at minimal 7 months, for OSUPD, it is estimated to 18 months.
    - 2. Officers are also trained (40 Hours) in mental health crisis to support the community.
- 1. OSUPD presence and resource sharing on regional campuses.

- m. Does OSUPD have a way to trace phone calls to OSU phones? How does OSUPD manage threats of violence made via phone calls? Can they work with another agencies / City of Columbus to better track them.
