Old Business

- 3. Presentation by Student Life Business and Financial Services (Dan Huffman)
 - a. Variety of financial sources in Student Life and 850 different budgets
 - i. Auxiliary (e.g., Housing, Dining, Union, Student Health Services)
 - 1. Generate revenue
 - 2. Limitations include needing BOT approval on rate increases, fees are locked or restricted based on the tuition guarantee, and no external funding sources support
 - 3. Must build reserves for long-term facility improvements and must cover short-term deficits
 - 4. If any auxiliary brings in more money than it spends in a year, those funds go into reserves for long-term projects (e.g., deferred maintenance)
 - 5. For facilities, goal is to put 2% of the value of the building into reserves each year, though we are lucky when we hit 1% right now because of the increases in utilities, labor costs, etc. without being able to increase rates
 - ii. Fee-based (e.g., SAF, Rec Fee, Ohio Union Facility, General Funds, Student Health Insurance)
 - 1. Advantages are that we can expect a generally predictable amount and can carry forward a surplus (as opposed to surplus in auxiliary, which must be directed into reserves)
 - 2. Limitations are similar to auxiliaries e.g., fixed rates that need BOT approval to be changed, no external funding support

- 3. Must be strategic and resourceful, since no increases are provided for wage increases (i.e., must decide to shift funds)
- 4. What will happen with the Ohio Union Facility Fee when the debt service is paid off? Too early to know, but a decision will need to be made about whether the fee will continue and/or be designated for the Ohio Union.
 - a. Any money collected right now must go toward debt service or be directed into reserves; cannot currently use for operating expenses
- iii. Development funds
- iv. Plant funds (for facility repairs, upgrades)
- v. Central support units are funded through a percentage of the other budgets
- vi. Annual planning process
 - 1. Fiscal year runs from July 1 to June 30
 - 2. Budgets assembled in Jan./Feb. and submitted in March
 - 3. Forecasts done in spring, summer, and autumn to update based on enrollment changes
- vii. SL budget: total of ~\$319M earnings account for 81% (~\$260M), general funds 15% (~\$47.5M), other 4% (~\$11.4M)
 - 1. Development brings in ~\$1M annually
- viii. SL doesn't have any influence on how money is invested; that is all determined by treasury office
 - ix. Mandatory Fees
 - 1. Rec Fee generates \$13.9M
 - 2. Union Fee generates \$8.1M (\$7.9M goes to debt service)
 - 3. SAF generates \$4.5M
 - x. FY25 Planned uses
 - 1. Salaries 28% (67.1M for staff, 1.3M for GTAs, \$18.1M for students)
 - 2. Benefits -8% (rate = $\sim 36\%$ of salary)
 - 3. Fee Authorizations/Student Aid 1%
 - 4. Supplies and Services 13%
 - 5. Cost of Sales 10% (primarily food)
 - 6. Utilities 5% (expecting another 8% increase for FY26)
 - 7. University Overhead 3%
 - 8. Non-Capital Expenditures 2%
 - 9. Capital Expenditures 2%
 - 10. Debt Service 21% (like mortgages on our facilities)
 - 11. Transfers Out 7% (e.g., STEP, FOD contract work, some regional campus)
- xi. Student Wages
 - 1. Minimum hourly rate moved to \$13/hr. on Jan. 1, 2024 in SL and June 30, 2024 for other units

- a. Increased by 50% since 2019 (\$8.55/hr.)
- b. Students work less hours than before COVID
- 2. No new funding came with these increases, so had to be accommodated with current budgets
 - a. Have had to evaluate things like building hours, staffing levels, etc. to find out how to cut costs
- 3. Impacted student wages at all levels of employment (compression affecting student managers who were already making that wage)
- 4. Some positions had to have their rates reevaluated to be competitive (e.g., lifeguards, dining)
- 5. Trying to find the right balance of continuing to offer a high level of service while also reducing our operating expenses
- xii. What kind of facilities have debts? Majority is Housing (North District), but also Union, Rec Facilities, Younkin, some on regional campuses
- xiii. Challenges include rising costs of utilities, wages, and supplies; deferred maintenance, and minimal, if any new funding
 - 1. Cash funding or short-term funding are also challenges when the funds run out (e.g., Ohio grant for mental health resources that expire this year)
- xiv. How we address the challenges
 - 1. Cost reductions from evaluating programs/hours, supplier contracts, adjusting programming/events
 - 2. Always looking for new revenue opportunities through SL Events and Conferences, sponsorships, development
 - 3. Continually engaging in start/stop/continue planning exercises
- xv. How can students be involved?
 - 1. Various councils that contribute to decisions about fees (e.g., CSA, RHAC, Student Governments)
 - 2. Attend and encourage attendance at events to demonstrate value
 - 3. Complete surveys from Center for the Study of Student Life

7. Code of Student Conduct Targeted Update

- a. Ad hoc committee that met last fall made recommendations for some updates to the Code and to relevant sections of the Faculty Rules

- c. Ad hoc committee decided to withdraw its Faculty Rules recommendations so that Faculty Council could deal with those themselves
- d. By the next CSA full council meeting, there should be some updates about the ad hoc committee's work, and CSA will have to decide whether to proceed with

- recommending the changes now or pause so that any changes could be packaged with additional changes that might result from the Student Conduct program review
