Hello everybody,

Thank you all for taking the time to vote on our alternative distribution plan last week. I'm happy to say that 10/10 votes were "Aye", meaning that we met the minimum 2/3 for approval.

After sending that proposal out, I was alerted that we once again skipped a step in our operating procedures which call for a simple majority vote to proceed with an alternative plan before holding a vote on the plan itself (which we just voted on). In spirit of our new policy, and the sake of expediency, Dr. Mull and myself are seeing that 10/10 vote in favor of the alternative distribution plan an approval by extension of the vote we skipped. I'm asking that if anyone objects with moving forward with the alternative plan that you all approved to please alert me by midnight tomorrow (3/4).

If anyone objects, we will go back to that step of the process which was unintentionally skipped, however if we're all in agreement that the overwhelming vote in favor of the alternative distribution plan.

In the spirit of moving forward, Allocations has made a request for \$50,000 from the excess Student Activity Fee cash balance.

I'm looking for three potential responses to this email:

1. Objection to moving forward with this process. If one person objects, then I'll fairly accept that objection and we will go back to the step that was skipped.
2. An "Aye" vote on approving \$50,000 to Allocations for the remainder of this fiscal year.

3. A "Nay" vote on approving \$50,000 to Allocations for the remainder of this fiscal year.
