Approval of Meeting Minutes (Oct 12, 2020)

- 1. Office of Student Life: Updates with Dr. Shivers, VP for Student Life
 - a. First Game of Football Season Weekend Recap
 - i. Increased issues with socials, physical distancing, and mask mandates in the off-campus area; approx. 36 reports
 - ii. Looking to adjust plans for the Penn State game and future events --hoping to create ways to establish community amongst first- and secondyear students
 - iii. Question: Were there instances of events hosted by SFL organizations or did Block happen?
 - iv. Addresses are still being sorted but the SFL community served as leaders within the community. However, there were some unrecognized organizations who did host events over the weekend
 - b. AVP Searches
 - i. All three 3 positions have been listed for national searches --- the applications have closed and candidate interviews will begin prior to winter break
 - c. Safety & Well-Being Task Force
 - i. Feedback loop sessions and committee meetings are on going
 - ii. Student life is addressing and acknowledging safety beyond law enforcement and police. Working extend beyond policing but rather community and relationship building. For example, lighting, education, and communication have been brought up as safety issues.

New Business

- 3. SAF, the opt-out, and student involvement in programming (Dr. Couch & Brittany Crall)
 - **a.** Previously, CSA approved a ticketing policy that allowed individuals who do not pay the SAF to attend OUAB events after Columbus campus students who have paid the fee have claimed their tickets.
 - i. With virtual events, the restrictions have removed and all with OSU logins can attend --- now, 21% of attendees are non-fee-paying attendees
 - ii. Conversation with John Mulaney was the most attended event thus far 22% were non fee-paying attendees
 - iii. The new method has increased opportunities for regional campus students
 - iv. No capacity issues with virtual events so far (if there was ever an issue, OUAB would follow the former guidelines)
