- 1. Rec Sports (Zach Snyder)
  - a. Adjustments are continuously made to ensure safety and comfort of all patrons
    - i. Masks must be worn and you must show a complete Daily Health check before entering the facilities
    - ii. Temperatures can be taken onsite and they can complete an OSU Qualtrics form if they do not have access to a smart phone they will receive a sticker verifying completion
  - b. Contingency plans are ongoing for extending hours once the state curfew changes

  - c. Staff redeployments have taken place to meet University needs
    - i. Many staff members are serving in quarantine and isolation housing

  - e. Stark differences in patron numbers from last year (pre COVID-19 approx. 1 million users; current approx. 340,000)
