 - iv. Regional campus dean can select students they want to put forth for position and then USG would select from those students

 - a. USG: Kelsey Lowman
 - i. One-year anniversary of USG incorporating Black History Month
 - ii. MCC and other student orgs are putting on a lot of events and programming this month for Black history encourage the members of your orgs to participate
 - iii. Two weeks ago OSU provided a delegation at Big 10 conference
 - 1. Widespread access to menstrual projects
 - 2. John Lewis voting rights act and making it a holiday so students can participate in voting
 - iv. Recently welcomed five new senators and more adequate student representation
 - b. CGS: Stephen Post
 - i. Grad Associate Performance Award for a graduate student that is a parent application is live
 - ii. Elections are coming up for CGS
 - iii. Followed up on enrollment review committee and they were not able to get a student representative on that committee
 - iv. Advocating for funding for folks that have been impacted by COVID-19
 - v. Looking for updates on Workday

 - i. Results of diversity and inclusion townhall and survey
 - 1. Each of professional schools had a representative and discussed the events of last summer and what each school can do moving forward
 - 2. Survey was sent out to those that attended and identified some concerns from those in attendance
 - 3. Recruiting more students of color and how we can support them while they are in professional schools

- 5. Office of Student Life: Updates with Dr. Couch, CSA Administrator
 - a. Two AVP positions are wrapping up interviews this week
 - b. As of Friday, we are able to resume events of 10 people or fewer
 - i. Most spaces are being used for classrooms so we may run into issues looking for spaces for student events to meet
 - c. Started to administer Students with Families survey to get input from students who have partners or children that depend on them and what needs they have when it comes to housing
 - i. Available until Friday the 19th
 - ii. Sending this survey to all students because we do not have much data on which students have dependent families and which do not
 - d. There is a regional campus project that DaVonti' is spearheading for the Office of Student Life
 - i. Invited all of student life staff on regional staff to be in a focus group to learn how we can better communicate and offer our resources to regional campuses
 - ii. End of April a report will be written up and shared
 - e. New Dean of Students is starting at the end of March
