- 1. **Dr. Micky Sharma,** Director Counseling & Consultation Services (CCS)
 - a. CCS has adjusted to meet the needs of students with multimodal resources and services. The Office is working to help students through understanding the various levels of needs.
 - b. CCS offers the following: brief individual counseling, group counseling, outreach and workshops, couple's counseling, drop in consultation, after hours on-call support, psychiatry.
 - c. More services have been added to serve graduate and professional students.
- 2. **Dr. Todd Suddeth,** Executive Director Multicultural Center
 - a. The Center is still open for in person engagement (with limited hours and capacity in physical spaces); many programs and services are offered virtually
 - b. Workshops, Heritage & Awareness Celebrations, Social Justice Engagement, and Cohort Programs are still ongoing.

- 3. Resolution on Renaming University Buildings (Kelsey Lowman)
 - a. Resolution was discussed following two Student Life presentations
 - b. The resolution urges the University Senate to rename Bricker Hall with a recommendation by the student body to rename the building after Doris Weaver.
 - i. Haynes posed a suggestion to redact her name from the until permission has been provided by Weaver and her family.
 - ii. Motion was made to table, it was seconded, with more discussion,
 - iii. Important points of discussion: There is a need to include mention of the current, in-place university policy on naming and renaming buildings, "Naming of University Spaces and Entities," last revised with Board of Trustees approval in June/July 2020. (this document is in the agenda folder)

Final vote to table: 7 in favor, 2 against, 1 abstain, so the resolution was tabled with a recommendation that it be considered by Issues Committee before coming back to full Council.
