1. CSA Elections Procedures

Article III Membership

Section E. Elections

Elections shall take place at the last regularly scheduled meeting of the term.

“CSA serves as the principal link between students, the student governments, the faculty and administration to encourage a sense of community and improve the quality of student life on campus.”



- a. The Council Chair shall be elected to a one-year term. For purposes of this election, all incoming and continuing members shall vote; outgoing members may vote as alternates if appointed to do so by an incoming or continuing member.
- b. The Vice Chair shall be elected to a one-year term. The Vice Chair must be a faculty or staff member of the Council. For purposes of this election, all incoming and continuing members shall vote; outgoing members may vote as alternates if necessary.

Article VI Issues Committee

Section A. Membership

...The chair of the issues committee shall be voted on by the members of the committee at the **first meeting of the academic year** and must be a member of the Council.

Article VII Allocations Committee

Section A. Purpose

...The chair shall be elected at the **first meeting of the academic year** from the voting student members of the committee.
