  - b. Student Life Strategic Plan
    - i. Designed to help us have a roadmap for where we are going
    - ii. This is a two-year plan intentionally to allow for nimbleness and change
  - c. Vaccination rate is at 90%
    - i. Encourage students to admit an exemption or proof of vaccination
    - ii. After Nov. 15<sup>th</sup> if nothing is submitted, they can only participate in online learning and experiences
  - d. Student safety
    - i. 84% decrease in crime in University District from July
    - ii. There is not a pathway to understand which mechanism is helping the most in decreasing crime a deeper dive will be taking place soon
      - 1. Engaging more with landlords and property owners
      - 2. Cameras
  - e. We will be almost back to 100% in person classes in the spring
    - i. Has OSU considered hybrid classes and students who want to maintain online classes?
  - f. 16,000 meals have been delivered since August using the rovers
  - g. Student mental health
    - i. In June, President Johnson requested a report on how we can support student's mental health and commission was formed to report recommendations
    - ii. Next, step is showing Board of Trustees due to 3.5-million-dollar request
