- 1. University Safety Taskforce (Nick Messenger)
 - a. Task force has been convening each Tuesday and Thursday mornings
 - i. Great engagement and parents have been heavily involved in feedback sessions
 - ii. Proposed Recommendations:
 - 1. Expand and enhance the Community Ambassador program; create and launch a safety class targeted for community members living off-campus
 - 2. Enhance the existing cultural diversity and implicit bias trainings; expand surveillance coverage in the off-campus neighborhoods; evaluate lighting and landscape in the off-campus neighborhoods; increase join patrol
 - 3. Reintroducing the community crime control under Student Life; conduct a campus safety survey; strengthen partnerships with community organizations and partners in the University District
 - b. Context for "existing community policing programs"
 - i. OSU does not operate with legal authority off-campus.
 - 1. 2008 OSU training officers are now present with CPD officers for Joint Patrol; the officer is trained and hired by OSU and aware of resources for mental health, sexual assault, or legal services
 - 2. 2011 Adoption of a new mutual aid agreement which gave OSUPD the legal authority to respond/patrol the campus area under certain circumstances
